



Foliar Liquid Nutritional

## INFORMATION

Sun Glo 14-7-7 *Plus* is a liquid foliar formulation designed for maximum uptake of readily available critical macronutrients. Since Sun Glo 14-7-7 *Plus* is easily assimilated by both leaves and woody tissue, it is very effective as a foliar spray to prevent and correct deficiencies on fruit, woody ornamental and most other crops. To ensure compatibilities a jar test is recommended before mixing with other products other than water in the tank. Always fill tank with water first, then begin adding Sun Glo 14-7-7 *Plus* while tank is circulating.

## DIRECTION FOR USE

Sun Glo 14-7-7 *Plus* should be applied as needed starting with the first spray at 7 to 10 gallons per acre for fruit trees (1-2 gallons per acre for Row crops) with sufficient water to completely cover leaves. Moisten both sides of the leaves only to the point of run-off. This is a very stable mixture that needs very little or no agitation.

## CROP RECOMMENDATIONS

Fruit Trees: Apply 7 to 10 gallons per acre per application at 5-10% bloom. Repeat as needed in mid season or three to four weeks before fruit harvest or as needed as a supplemental source of nutrients.

Row Crops: Apply 1-2 gallons per acre per application in sufficient water and wet to run off at critical stages of growth.

Woody ornamentals: 3-5 gallons per acre is the recommended rate. Repeat every 3-4 weeks as needed
